**Authorizations:**

- I hereby give UCA permission to electronically apply my financial aid (Federal, State and Institutional) to ALL mandatory and contracted fees associated with my attendance at the university. These fees include, but are not limited to, Tuition, Mandatory Fees, Room & Board, Books and Fines.
- I authorize UCA to use current year funds to pay minor prior year expenses, less than \$200. Prior term expenses/charges are expected to be paid prior to enrollment for the next term of enrollment.
- I understand that these authorizations are not mandatory and are valid for one year and that if I wish to rescind this authorization I may do so by notifying the Student Accounts Office in writing. If I do not authorize the processes above, I understand that I will have to pay all contracted fees, as well as minor prior year expenses before any federal financial aid will be disbursed to my account or to me.

**Student Loan Recipients:** You must be enrolled at least ½ time to receive a federal Stafford, GRAD PLUS or PLUS loan. For an undergraduate student, ½ time is 6 undergraduate credit hours. For a graduate student, ½ time is 5 graduate credit hours.

- Students will initially be awarded assuming full time enrollment for fall and spring. Eligibility will be recalculated after the official aid period has ended (usually the 4<sup>th</sup> day of classes) to reflect your true enrollment status. This may cause a reduction of the funds you are eligible to receive.
- I understand that if I stop attending before the 61% of the semester, whether or not I officially withdraw from courses, I will owe a repayment of my federal student aid. Students who receive all F's at the end of a term are assumed to have ceased attending at the mid point of the semester, unless they can document otherwise.
